**Young Artist's Solo Competition Rules
2019-20**

1. Sponsors include West Side Baptist Church, Senseney Music Inc., EMC Insurance Companies, Inc., and the Delano Chamber Players, Inc.
2. The competition, rehearsals, and performance will take place at West Side Baptist Church 304 S. Seneca, Wichita, KS.
3. The competition will take place on Saturday, February 1, 2020. Contestants will be provided with specific audition times in advance.
4. Applicants are limited to high school seniors graduating in 2020 or their home school equivalents. Students are expected to be involved in some way in the music program of their future college, university, or conservatory but are not required to declare a major in music.
5. Applications will be accepted from musicians in two categories:
 - A. Strings (violin, viola, cello, double bass, and harp);
 - B. Woodwinds (flute, oboe, clarinet, and bassoon);
 - C. Brass (french horn, trumpet, trombone, and tuba).
6. Judges are not obligated to pick a winner. If a winner/s is/are chosen, scholarships will be awarded in the amount of \$500 for the first place winner, \$250 for the second place winner, and \$100 for the third place winner.
7. Applicants must submit two (2) letters of recommendation, one each from:
 - A. Their private music instructor;
 - B. Their high school director, youth orchestra conductor, or prominent community musician.
8. The letters of recommendation and application must be received by David Martin, General Manager, Delano Chamber Players, 2448 Cardinal Drive, Wichita, KS 67204, no later than January 18, 2020.
9. Selection of winners will be based on the following audition criteria:
 - A. An ascending and descending major or minor scale of three octaves, played in any style. Modifications are acceptable for instruments whose full range is less than three octaves.
 - B. Two contrasting excerpts from standard orchestral literature; each excerpt should be no more than one minute in length.
 - C. A performance of the solo work, with piano accompaniment, mutually agreed to by the applicant and the Music Director/Conductor. The applicant or private teacher must contact Dr. Wesley DeSpain to gain approval for the work to be performed. Email: wesleydespain@gmail.com; Cell: 316-734-3511
 - D. The work to be performed must be available for purchase. *The DCO does not perform music for hire (rentals) due to budgetary concerns.*
10. Competition winners will perform with the Delano Chamber Orchestra on Sunday, April 19, 2020, at 3:00pm.
11. Attendance at all four rehearsals prior to the concert is required. The rehearsal dates are Thursday, March 26, Thursday, April 2, and Thursday, April 16, from 7:00-9:00pm, and Saturday, April 18, from 3:00-5:00pm. Dr. DeSpain will provide soloists with specific rehearsal call times.
12. Soloists are encouraged but not required to perform from memory. Winners must perform the work listed on their application and heard at the audition. Multiple movement may be performed if approved by Dr. DeSpain in advance.
